Overview

Article I of Protocol I from the European Convention of Human Rights states that "every natural or legal person is entitled to the peaceful enjoyment of his/her possessions". For every EU citizen rights come with certain duties, yet in the case of condominium property this balance is not always so straightforward. Can we still perceive condominium property as a first class right?

In the occasion of the 2019 UIPI Property Day, hosted by the Hungarian Association of Condominiums and Condominium Managers (TTOE), we will shed light on the challenges and possibilities stemming from condominium property. The discussion will also serve as a way to share experiences coming from other Member States in order to identify the common challenges and possible best practices to fully benefit from co-ownership.

Stratos Paradias

Stratos Paradias is the President of the International Union of Property Owners (UIPI) since 2005. Stratos is a Supreme Court lawyer in Athens, specialised in property law. In 1983, he founded the Hellenic Property Federation (POMIDA) in Athens, and he is its President since 1996. He was a member of the Greek State Committee for Legislation, for Codification of the Commercial Rentals Law, as well as a member of the State Committee for the Taxation of Real Estate Property and the National Council against Tax Evasion. Stratos is a graduate from the Law School as well as the Political Sciences School of the University of Athens.



Dr. Agnes Bek

Dr. Agnes Bek is the President of the National Association of Condominiums and Condominium Managers (TTOE), and condominium expert on Kossuth Radio's Daytime. She is a lawyer graduated from the Law University of Pécs and an experienced legal adviser that has served the Hungarian Government for several years in the sectors of Housing, Urban Planning and Mobility. She was lecturer at the Advisory Forum in District I. For over 15 years Dr. Bek has been educating legal accountants and tax consultants in the organization of OKTÁV Zrt.



Dr. Izsak Orsolya

Dr. Izsak Orsolya is an independent lawyer and the founder of her own Law Firm. She has been practicing law since 2004. She was a legal lecturer and she also gained administrative experience first at the Hungarian Energy Office and then as a parliamentary secretary at the Parliamentary Secretariat of the Ministry of Agriculture and Rural Development. She deals mainly with neighbourhood issues with their civil and construction legal aspects.



Avv. Vincenzo Nasini

Avv. Vincenzo Nasini is civil lawyer and expert in legal and tax matters related to the real estate sector. He is President of APE Confedilizia of Genoa since 2009. He is the responsible of the Condominium Coordination of Confedilizia and President of the Study Center CORAM since 2005.
